- I. Meeting opened with introductions and agency updates. Referrals are steady across the region. Ages and Stages Questionnaire is now available with an online option.
- I. Motion for approval of the agenda was made by Connie Fragodt, seconded by Cindy Kvaal. Motion carried.
- II. Motion for approval of Minutes from September 27, 2023, was made by Amy Stock, seconded by Marge Knudson. Motion carried.
- III. IEIC Region 6 promotional videos to encourage parent referral and intervention participation assignment check-in. A few shared they had not shared it with their social media, coworkers and organizations. Movie Theater Advertising is available in Spicer, Montevideo, and Hutchinson. Madison is doing national ads only. Canby has contracts reserved through 2024. A motion to spend up to \$6500 among the theaters was made by Connie Fragodt, seconded by Jody Ammerman to air and revise to 30-second spot. It should include a QRC and reach out to your local school district.

The YouTube links were shared with Region 11 Metro and statewide marketing contact. They will be sharing the videos on social media, other IEICs, and placing on helpmegrowmn.org resources page.

IV. Financials update includes a budget of \$10,064.79 unallocated due to over \$8,000 carryover from FY 2023. Region 6 is partnering with Region 8 at Kids First Conference at Jackpot Junction on March 1-2. Linda Mathiasen will be presenting two Develop approved breakout sessions on Challenging Behavior sponsored by IEIC Region 6. A Help Me Grow message and materials will be shared.

Cat Tamminga is willing to submit a request for materials since attendees will be drawn from more than Region 6. If needed, a motion by Marge Knudson, seconded by Darla Swedzinski was made to purchase vendor booth materials of up to \$1,750 and using current inventory. Motion carried.

Request for Diversity Training for child care providers to understand family values toward raising children was tabled until February 28, 2024. Linda Mathiasen is currently taking DEIAB train-the-trainer courses through MDE/IEIC. These will not be complete until May or June 2024. The request was specifically for insight into Spanish speaking families. She is willing to partner with Hispanic/Latino guest speakers. She is also willing to identify possible partners/speakers too if this is an interest. A suggested speaker is Anna Snyder.

V. Time Request per Linda Mathiasen's contract, 12 hours is allowed to attend a MDE Retreat in Mpls. There is no retreat scheduled for this fiscal year. Instead, there was a Children's Mental Health conference that was held Nov. 5-7. A motion by Jody Wambeke, seconded by Tina Saue for up to 12 hours to be re-allocated for attending this training that was Develop approved and applies to ongoing CEUs needed and provided valuable insight that is applicable to her IEIC outreach and training. Linda Mathiasen is to verify with Cat Tamminga at MDE and SWWC for second review at February's meeting.
