b. 2024-25 Regional PD for Superintendents' Plan – Shelly Maes

MASA rotates PD money to regions and SWWC will receive money this year. Based on feedback from the survey, leadership and innovation were topics of interest. One option discussed was to have Wade McKittrick, Better Solutions, provide 6 types of working genius, creating innovative solutions and leadership professional development. Another piece is to provide costs for School Finance Training that has been held. Discussion was held and Shelly will work with the Executive Committee of the Superintendents' Executive Council to look into additional opportunities.

c. 2024-25 SWWC Staffing Update - Abby Polzine

Since July 1, SWWC has hired 66 new employees. We have 20.5 positions open yet. Eleven of these are teaching and para positions. 47 Total SWWC Employees. There is a need to look at different ways of staffing.
