Cliff Carmody provided an update on the July 1, 2024, Insurance Pool Renewal. The Pool lost five large groups and one small group totaling 589 contracts and renewed one large, eleven small, and added one new group for a total of 723 contracts. The renewal was challenging with efforts needing to continue on competing with others.
